## Terms and Conditions for Non-Tuition Fees: Other Additional Costs

#### **General Points**

#### 1. Invoice and Payment

- Invoices for non-tuition fees will be sent to parents/guardians.
- Payment is due by the date specified on the invoice, generally within 30 days of receipt.
- Late payments may incur additional charges or penalties as per school policy.

#### **Specific Points**

#### 1. School Trips and Residential Trips

- Invoices for school trips and residential trips must be paid in full before the trip commences.
- The school reserves the right to refuse participation in the trip if the invoice remains unpaid.
- 2. Swimming Pool
- Swimming is a compulsory part of the primary school curriculum.

#### 3. Lockers

- A deposit of CHF 25 is required for a new locker upon a student's arrival.
- If a student loses their locker key, the deposit will be used to cover the cost of a new key.
- The deposit will be refunded when the student leaves the British School of Geneva, provided the locker key is returned.

#### 4. Calculators

• For KS3 Students basic calculators are provided as part of the curriculum. If a calculator is lost, a replacement deposit of CHF 50 will be required. KS4 calculators are charged CHF 130 each.

#### 5. Learning Support

- Prices for learning support services are available upon request.
- An agreement outlining the terms and cost of learning support will be made between parents/ guardians and the academic Head of Section.
- Once the agreement is signed, learning support services will commence and must be paid on a termly basis.
- In the event of a student or teacher's absence, the teacher will reschedule the missed lesson within the following month or provide a substitute lesson.

#### 6. Private Tutoring

- Prices for private tutoring are available upon request.
- An agreement outlining the terms and cost of private tutoring will be made between parents/ guardians and the academic Head of Section.
- Once the agreement is signed, private tutoring services will commence and must be paid on a termly basis.
- In the event of a student or teacher's absence, the teacher will reschedule the missed lesson within the following month or provide a substitute lesson.

Please ensure all payments are made promptly to avoid disruption to the student's participation in school activities and access to necessary resources. For any queries regarding these terms and conditions, please contact the school administration office.
