## FEES & PAYMENT TERMS 2019-2020

### REGISTRATION FEE

An annual fee of CHF 900 covers the administrative cost of processing admissions, and is payable at the time of enrolment or re-enrolment. This fee is non-refundable, except in cases where the school is unable to offer a place.

### CAPITAL DEVELOPMENT FEE FOR NEW STUDENTS

A one-time fee of CHF 3'000 is applied only in a student's first year at the British School of Geneva, and is payable upon enrolment. This fee is put toward the ongoing maintenance and improvement of our learning environment.

For children arriving during the course of the academic year, the Registration Fee and Capital Development Fee are payable in full.

### TUITION FEES AND STANDARD TERMS OF PAYMENT

The following fees include the cost of books, materials and lunchtime supervision.

Tuition fees will be charged on a termly basis for students arriving during the academic year.

### FLEXIBLE TERMS OF PAYMENT

A monthly payment plan is available, upon request and in agreement with the Principal, for families paying school fees privately. Under the same conditions, a sibling discount may apply to families with three or more children in school (see general Terms and Condition for details). All fees for students sponsored by companies and international organisations are payable according to standard terms.
